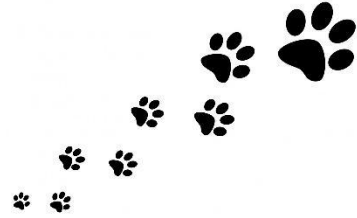

1. I hereby certify that I am the owner of _____, the dog(s) which will take part in Dog Day Care and/or Boarding at GilLikays Pet Getaway.
2. I understand that additional dogs will attend Dog Day Care and/or Boarding and that during the period of participation, my dog may come into direct contact with other participating dogs.
3. I hereby certify that the above named dog(s) have the up to date following vaccinations: canine distemper, canine parvovirus, canine parainfluenza, as well as Bordetella (kennel cough), and rabies. The requirements to attend Dog Day Care and/or Boarding at GilLikays Pet Getaway are DHPPC within the last year, Bordetella within the last 6 months, and rabies according to the local laws of New York State. I am fully knowledgeable that my dog may be exposed to those infectious diseases described above. Nevertheless, since GilLikays Pet Getaway has advised me that my dog must be fully vaccinated against those diseases before attending Dog Day Care and/or Boarding, I alone am responsible for any exposure to the diseases described.
4. I comprehend that in the occurrence of injury or illness during their stay, my dog will be taken to Emergency Animal Clinic, closely located at 208 Monhagen Avenue Middletown, NY 10940 unless your personal veterinarian is preferred and in close traveling distance to GilLikays Pet Getaway and available at the time of the incident.
5. Although the animal caretakers here at GilLikays Pet Getaway are attentively watching all dogs play along with leash walks on the premises, I am aware that with the unpredictable behavior of dogs, an interaction may take place between animals at the daycare or unpredicted events may occur while on scheduled walks. If an event as such concludes in injury to other dogs, or to other people and or animals on the property I alone assume responsibility for any such injury.
6. As to GilLikays Pet Getaway and its employees, I hereby waive and release any actions, basis of actions, damages, rights, claims or lawsuits which I may have for: (1.) any and all personal injury or property damage which may be concluded out of any interaction between dogs participating in Dog Day Care and/or Boarding; and (2.) any and all injury, illness or disease sustained by my dog arising out of its participation in Dog Day Care and/or Boarding.
